

# POLSAT PLUS ARENA GDAŃSK INFORMATION FOR VIEWPOINT

## HOW GET TO THE STADIUM AND PARKING SPACES

1. Entry to the Viewpoint is through the turnstile 9-10, preferably do through gate 4, 5, 6 and 8. There is a board at the viewing point that states that it is there.
2. Parking P3 and P4 near the stadium secretariat, which is available for passenger cars for the first 30 minutes it cost PLN 2,00 , the second 30 minutes cost PLN 2.00. Then later the first and each subsequent hour cost PLN 4.00. P3-A car parks for coaches payable first and next 2 hours of parking PLN 15.00/h, day cost PLN 50.00. Failure to pay for a parking ticket costs PLN 120.00. Payment can be made at the automatic parking counter located in the car park, the purchased parking ticket must be placed in car behind the windshield in a visible place. Parking P3 and P4 is free of charge for electric cars (with a green signboard).
3. The Stadium can also be reached by public transport. From the center of Gdańsk you can get by tram number 10 or number 7 , in Gdańsk Wrzeszcz by bus number 158. Name of the destination stop "Polsat Plus Arena Gdańsk".

## VIEWPOINT INFORMATION

1. The entrance to the Viewing Point is located on the upper outer promenade, to get to the viewing point, go to turnstile 9-10, scan the barcode on the ticket in the scanner, push the turnstile. **ATTENTION! One ticket entitles only 1 person to enter.**
2. The time of entering the Viewpoint included in the ticket is the time when you must use the attractions.
3. Each client must have a valid ticket to use the Viewpoint.
4. There are almost a hundred stairs at the Viewing Point, so we recommend that you wear comfortable shoes, and leave items such as bags, backpacks or prams at the stadium office. Attention! It is not possible to enter the Viewpoint with prams and car seats for children.
5. The use of the viewing point is at your own risk.
6. While staying at the Viewing Point, it is forbidden in particular to:
  - drop any items,
  - consume alcoholic beverages and use drugs on the premises of the Viewing Point,
  - smoke tobacco, electronic cigarettes and other intoxicants at the Viewing Point, inside and within the Stadium,
  - run around the Viewpoint and stairs,
  - litter,
  - land pollution,
  - bring animals, except guide dogs,

- make noise,
  - damage the structure of the Viewing Point and its equipment, destroy the equipment,
  - apply inscriptions on the construction elements of the Viewpoint and its equipment,
  - enter rooms marked with a ban on entry.
7. Visitors to the Viewing Point must strictly follow the instructions and comments of an authorized service employee, as well as instructions and recommendations, in particular the content of graphic signs and text or sound information addressed to visitors to the Viewpoint. Failure to comply with the above recommendations, including in particular the content of graphic symbols and text or sound information, entitles the facility manager to impose a contractual penalty on the Visitor in the amount of PLN 10000.00 for each case of violation. The manager of the facility is entitled to claim damages from the Visitor in excess of the amount of the contractual penalty.
  8. The staff of the View Point has the right to escort from the View Point people who violate public order or the provisions of the regulations, posing a threat to themselves and other people staying at the View Point, without reimbursement of the admission costs incurred.
  9. Arena Gdańsk Operator Ltd., as the manager of the facility, is not responsible for bodily injuries, other accidents as well as personal and material damage resulting from violation of the regulations, service instructions and general health and safety rules by visitors.
  10. It is inadvisable to enter the Viewpoint if you suffer from fear of height or space (agoraphobia).
  11. Toilets for visitors are located in the stadium office or in the Fun Arena. There are no toilets at the Viewing Point.
  12. The Viewpoint may be closed in the event of particularly unfavorable weather conditions, in which case the Visitors will be offered another date, if possible, and if it is not possible to set another date, the Administrator will refund the costs for unused tickets.
  13. The manager is not responsible for poor visibility resulting from unfavorable weather conditions.
  14. The provisions of these Regulations apply to all Visitors of the Viewpoint.
  15. The Administrator is not responsible for the safety of people staying at the Stadium
  16. The manager is not responsible for items left on the premises of the Stadium.
  17. Otherwise, the provisions of the Regulations of the Polsat Plus Arena Gdańsk Stadium shall apply.

## RULES OF PAYMENT AND TICKET PRICES

1. Ticket prices for the Viewpoint
  - ticket - PLN 13.00 / person
  - children under 4 - admission free
2. Tickets for the Viewpoint should be purchased via the website: [https://polsatplusarenagdansk.pl/punkt\\_widokowy](https://polsatplusarenagdansk.pl/punkt_widokowy)
3. To issue a VAT invoice, it is necessary to provide full data while filling in the application form.
4. A maximum of 100 people may stay at the Viewing Point at any one time.
5. The complete and up-to-date schedule of entries to the Viewpoint is available on the ticket page. Entrances take place every 30 minutes. The Viewpoint is open:
  - in the period from May to September: daily from 10.00 to 18.00 (last admission at 17.30)
  - from October to April: daily from 10.00 a.m. to 16.00 (last admission at 15.30)
6. In order to adjust the entrance to the Viewpoint, it is necessary to notify in advance by disabled persons (using wheelchairs).
7. The organizer reserves the right to postpone or cancel the availability of the viewpoint due to the ongoing football training sessions or mass events.
