Regulations regarding the use of the skating track

1. General ruling

1.1. The rollerskating area is an integral part of The Stadium and to the extent not covered by these Regulations, the provisions of the Stadium Regulations shall apply to the use of this area.

1.2. Whenever mentioned in The Regulations, bellow terms shall signify:

1.1.1. **Skating Track-** asphaltic pavement around The Stadium used in purpose of pedestrian traffic, wheeled vehicles other than mechanical ones.

1.1.2. **The Operator-** Arena Gdańsk Operator, limited liability company located in Gdańsk,

1.1.3. **Event mode-** Functioning of the stadium and systems during mass events and other parties (unqualified as mass events in the understanding of the rules in force) and the time needed to prepare the area of said events.

1.1.4. **User-** person using the Skating Track, a road user, in particular: pedestrians, roller-skaters, skaters and bikers, excluding those on a power-driven vehicle or a motorbike, within the meaning of the Road Traffic Law of June 20, 1997.

2. Availability of the Rollerskating Track

2.1. Within the opening hours The Skating Track is an open-access area and its use is free of charge for Users.

2.2. The Skating Track is open daily from 7 a.m. to 10 p.m., subject to Section 2.4.

2.3. The Skating Track is closed on days of The Event Mode.

2.4. The availability of the Skating Track may be limited in other reasonable cases as determined by the Operator.

2.5. Use of any mechanical vehicles is forbidden, subject to the following paragraph.

2.6. It is solely allowed for supply vehicles and those with a special permit from The Operator.

2.7. Any kind of practise and group rides shall require a prior consult and a written consent from The Operator as well as be secured in a professional manner.

2.8. It is advised to conduct practise and group rides outside the open-access hours.

2.9. Any kind of trading, gastronomic, service or artistic, including making broadcasts, radio or television recordings, filming or taking photographs shall only be conducted after a prior, written consent of The Operator.

2.10. The Skating Track is monitored.

3. Safety

3.1. On the track there is a speed limit of 15 km/h.

3.2. Before using The Skating Track The User is obliged to familiarize himself with the content of these regulations. Lack of familiarization with the regulations does not relieve the User from the obligation to comply with their content.

3.3. Each User is obliged to take care of his own safety and the safety of other Users while using the Skating Track.

3.4. Every User shall adjust the speed and style of his riding to his own skill, owned equipment and weather as well as take into consideration the speed and form of riding of other Users.

3.5. In particular it is forbidden to:

3.5.1. Use The Skating Track with the use of not fully functioning equipment;

3.5.2. Use the sanitary stations on roller skates;

3.5.3. Enter the Stadium Facility on roller skates;

3.5.4. Hold children while riding;

3.5.5. Cause danger to other Users of the track, including driving in the opposite direction, nudging, knocking, pushing as well as jumping, rapid braking, racing or doing anything dangerous;

3.5.6. Use of the Skating Track by people whose health condition does not allow it.

3.6. The direction of traffic on the Skating Track is counterclockwise. The user driving in the clockwise direction is required to exercise extreme caution and give way to those driving from the opposite direction.

3.7. Using body protective wear as well as a helmet is advised.

3.8. In the event that any work and repairs are carried out on the Skating Track, the User is obliged to use the Skating Track in a manner that does not obstruct the work, with the required caution.

3.9. It is forbidden to use the Skating Track to those under the influence of alcohol or other intoxicants and to consume alcohol or other intoxicants on the Skating Track.

3.10. Smoking is prohibited in the Stadium except in areas designated for this purpose.3.11. Each Participant is obliged to immediately inform the Operator or a

representative of the relevant law enforcement agencies, of any observed violation of these Regulations or applicable laws by another Participant.

4. Policing rules

4.1. When entering the Skating Track, the User agrees to abide by these Rules and Regulations and to obey the instructions of the Stadium's security personnel.

4.2. It is forbidden to trash and destroy the Skating Track as well as the infrastructure around the Stadium.

4.3. the User is obliged to take care of order and maintain the proper technical condition of the Skating Track.

4.4. the User shall be obliged to report to the Stadium staff any noticed destruction or damage if it may affect the safety of Users.

4.5 In the event of any damage caused by the User, the Operator shall pursue compensation from the User, and shall also take other actions necessary and provided by law.

4.6 Any person violating the provisions of these Regulations or generally applicable law shall be immediately removed from the Skating Track.

4.7 Each User of the Skating Track, uses it at his own risk (in case of minors, the responsibility is borne by legal guardians). Users who are under 13 years of age may use the

Skating Track only under the supervision of adults.

4.8 The Operator shall not be liable for any damages incurred by the Users, including those resulting from accidents or injuries, as well as damage to property occurring on the Skating Track, in particular those resulting from the use of the Skating Track in a manner inconsistent with the Regulations or the failure of the Users to comply with the safety rules set forth in these Regulations.

4.9 The Operator shall not be responsible for items lost or left unattended or stolen.
